## I. INTRODUCTION

The G20 is a strategic multilateral platform connecting the world's major developed and emerging economies. The G20 holds a strategic role in securing future global economic growth and prosperity. Together, the G20 members represent more than 80 percent of world GDP, 75 percent of international trade and 60 percent of the world population.

Starting in 1999 as a meeting for the finance minister and central bank governors, the G20 has evolved into a yearly summit involving the Head of State and Government. In addition to that, the Sherpa meetings (in charge of carrying out negotiations and building consensus among Leaders), working groups, and special events are also organized throughout the year.

## II. VENUE

The 17<sup>th</sup> G20 Leader Summit will take place in Bali.

G20 Indonesia consists a series of meetings (expected to number approximately 157) that will take place across Indonesia, Jakarta, Bogor, Semarang, Solo, Batam-Bintan, Medan, Yogyakarta, Bandung, Sorong, Lombok, Surabaya, Labuan Bajo, Danau Toba, Manado, Malang, and others are among the cities that will be involved.

## III. MEDIA ACCREDITATION/REGISTRATION

### Registration Process

1. Due to COVID-19 Pandemic and taking into account the **Regulation of the Minister of Law and Human Rights of the Republic of Indonesia Number 34 of 2021** on Visa and Stay Permits in the New Normal and the **Circular Letter of the Covid-19 Task Force No. 4 of 2022** concerning Health Protocol for International Travel during the Covid-19 Pandemic effective from February 1<sup>st</sup> 2022, permitted journalist visit to Indonesia is limited for the purpose of the covering of Ministerial Meeting and Leader's Summit of G20.

**Note:** The regulation may be renewed in accordance with the dynamics of the Covid-19 pandemic, globally and nationally.

2. The coverage for the G20 Indonesia's Presidency may be held virtually or on-site / in-person
3. To be present physically and covering directly from Indonesia will be enabled through these mechanisms:

#### A. Foreign Media from Abroad

##### a. Official Traveling Press

Journalists are required to be part of the delegates of the Minister or Leaders attending the G20 meeting in Indonesia (Holder of Service Visa).

**b. Invited Press**

Journalists are holder of the official invitation letter of G20 meeting issued by the focal point ministries of the meeting.

**Note:** Event Committee will publish the Media Circular Note on the <https://g20.org>, so the media may request the official invitation letter of G20 meeting.

**B. Foreign Media Residency in Indonesia and National Media**

**Invited Press**

Journalists are holder of official invitation letter of G20 meeting issued by the focal point ministries of the meeting.

**C. Official Media from Embassy**

Official media must be registered as part of the delegates of the Minister or Leaders attending the G20 meeting in Indonesia.

4. Every media representative except Official Traveling Press who covers the event must register at the media registration form available at <https://registration.g20.org>. Fill in the media registration form and attach the documents needed.
5. Upon media accreditation approval, an accreditation confirmation letter will be sent to your email.

**Note:**

Official invitation letter of G20 meeting and media accreditation letter must be submitted as attachments to journalist visa request to Indonesian Missions abroad.

Bear in mind: invitation letter, media accreditation approval and other supporting documents would not guarantee visa approval.

6. To cover virtually, journalists would also be required to complete the registration process at <https://registration.g20.org>. **On-site accreditation is not available.** All accreditation must be obtained prior to the meeting through the website.

**Health Protocol**

1. Media representative must comply with rules and regulation from the Government of Indonesia. Every media representative **must have complete dose of vaccinations certificate** and **fill in Statement Letter of Compliance**.

**Note:** Statement Letter of Compliance will be obtained once the accreditation completed.

2. All members of the G20 participants must have Covid-19 travel insurance that includes Covid-19 coverage and must show a negative RT-PCR test result in the country or region of origin which samples were taken within a maximum period

of 2 x 24 hours before the departure time, and comply quarantine rules in accordance with the **Circular Letter of the Covid-19 Task Force No. 4 of 2022**.

Media representatives must be completely vaccinated against Covid-19, as evidenced by a vaccination certificate for Covid-19. The Government of Indonesia is acknowledging all kind of vaccines approved for use by WHO.

3. To comply with Indonesia's Covid-19 health and safety standard, all foreign visitors must complete an Electronic Health Alert Card (EHAC) and authenticate their vaccination certificate through <https://vaksinln.dto.kemkes.go.id/sign/in> or through our embassy. Each foreign visitor has the option to access their own verification results on PeduliLindungi. The PeduliLindungi is a smartphone application that is used to track Covid-19 occurrences. As part of the country's protocol, all visitors to Indonesia are obligated to use it while they are in public places

**Noted:** Please refer to the Indonesian MoFA Circular Note from your respective embassies.

**PLEASE NOTE THAT INCOMPLETE REGISTRATION WILL NOT BE PROCESSED.**
